PERSONNEL AND PAY CLASSIFICATION PLAN

WHEREAS, KRS 83A.070(2) requires the legislative body of each city to fix the compensation of city employees and nonelected city officers in accordance with a personnel and pay classification plan which shall be adopted by ordinance,

BE IT ORDAINED by the city council of the City of West Liberty, Kentucky as follows:
